## **Department and Committee Reports:**

<u>Legal, Finance and Administration:</u> Clerk attended a clerks meeting in Hartland last week. The Budget meeting for the RSC will be held on Thursday night. Council to meet next week for budget meeting.

**Economic Development:** Coun McNair finalizing the results of the balloonfest. A couple of sponsors left to pay.

<u>Community Development:</u> Coun McIntosh reported a tree down on the NB Trail. Marven had a look at the wire and reported to NB Power. NB Power has not been back to repair the line. Coun McIntosh was concerned that someone would get hurt.

Coun McNair suggested a tool shed be built to store ball equipment at the fairgrounds and the building currently be used to be demolished.

<u>Public Safety:</u> Coun McNair and Coun McIntosh attended a Trails meeting this month. The Trail committee has \$9 M of funding to create a cycling trail from Grand Falls to Woodstock.
