Committee Reports:

<u>General Government:</u> Mayor Stone working on audit. Waiting for figures from Dillon Consulting for the fixed assets to finalize year end.

<u>Finance Committee:</u> The financials to the end of February show a small surplus in both the General and Utility Funds.

<u>Public Safety:</u> There was a policing meeting tonight in Woodstock. Mike was unable to attend because of the regular council meeting, usually meetings are held on Tuesday. Mayor Stone met in Rockland with area mayors and government officials on the matter of regionalization of services in the province. The province is made up of 12 municipalities. Each one of these regions will have a spokesperson that will represent the municipalities and LSD's.

Web site is almost finished. Plan to put financials and bylaws on the site for residents to view.

<u>Public Works</u>: Marven asked Wendell Hooper from Maritech to look at the lift stations and see what is needed to put alarm systems on the stations to prevent an overflow.

Matt Kilfoil to build a building at the tank to put all the electrical work for the tank above ground. Size will be 6X6 and insulated. Marven is trying to arrange for corrosion services to come an install a panel for the building. Marven is getting quotes from area businesses on a new tractor.

Water usage is still up a bit, water usage runs about 50000 gallons a day. Water meters are in and clerk will contact residents who wanted one. Marven received the wastewater approval certificate for 2012.

<u>Community Services:</u> There has been a few issues with garbage not being picked up. Clerk contacted Kearneys and they will address the issue.

Marven will draft a notice to go in the next water billing about what the village has spent over the past few years in water and sewer infrastructure and where the money is being spent so that residents can better understand where the money is be used.

Transportation: Mike to call DOT about pot holes on Main and Hospital Street. Mike to call Tony and see if this his responsibility first.

New Business: On **Motion** that the clerk be authorized to issue and sell to the New Brunswick Municipal Finance Corporation a Municipality of Bath debenture in the principal amount of \$23000.00 on such terms and conditions as re recommended by the New Brunswick Municipal Finance Corporation, and be it resolved that the Municipality of Bath agree to issue post dated cheques payable to the New Brunswick Municipal Finance Corporation as and when they are requested in payment of principal and interest charges on the above debenture.
